### 2.3. Other hazards

Other hazards which do not result in classification : Can occur: eye irritation, irritation of mucous membranes and skin irritation. During machining the product (drilling, cutting, sanding, etc.), airborne dust can be released. As with most types of nuisance dust, excessive inhalation of dust may cause irritation of the bronchial tubes. Some raw materials may contain traces of natural occurring quartz. The inhalation of quartz containing dust, in particular the fine dust fraction (respirable size), in high concentrations or over repeated or prolonged periods of time can be hazardous to health and may lead to chronic lung disease and an increased risk of lung cancer.
