PRODUCT DESCRIPTION

This EPD is representative and relevant for the following PROMASEAL® products: PROMASEAL®-A and PROMASEAL®-AG. Both products are produced by Etex Building Performance GmbH, Austria. The results in this EPD are based on one kg production of the PROMASEAL®-A. The representativeness of the PROMASEAL®-A has been checked by comparing its results with the results of the other covered product in the EPD, i.e., PROMASEAL®-AG. The comparative analysis confirmed that the maximal variation is below the allowable limit for the GWP-fossil for A1-A3 and as a result, PROMASEAL®-A is considered as representative in this EPD.

PROMASEAL®-A is an acrylic-based, single component fire stopping sealant. Joints without movement can be sealed quickly and securely thanks to its outstanding application qualities. A common emulsion paint can be used to colour the joints. PROMASEAL®-A is a fire stopping sealant for joints in walls and floors. It can also be used as an annular clearance seal between structural components and non-combustible sustained insulation. The product has test certificate / approval: EN 1366-4; EN 13501-2 and ETAG 026-2/3.

PROMASEAL®-AG is an acrylic-based, intumescent, single component fire stopping mastic with high expansion factor. PROMASEAL®-AG is a fire stopping sealant for walls and floors. It is designed for use with cables, cable bundles, conduits, combustible and non-combustible pipes with combustible insulation to prevent the spread of smoke, fire and heat. The product has test certificate /approval: EN 1366-3; EN 13501-1/2 and ETAG 026-2.

MANUFACTURING AND PACKAGING (A1-A3)

The environmental impacts considered for the product stage cover the manufacturing of raw materials used in the production as well as packaging materials and other ancillary materials. Also, fuels used by machines, and handling of waste formed in the production processes at the manufacturing facilities are included in this stage. The study also considers the material losses occurring during the manufacturing processes as well as losses during electricity transmission.

Transport for raw materials considers the distance from the extraction or manufacturing location of the raw material to the production plant and the modelling of the relevant transportation type (e.g., bulk sea fret, road lorry, train, ...) for each raw material. Regarding the energy used, 100% of the electricity (as the only source of the energy consumption) which is used in the manufacturing plant is sourced from renewable sources (a mix of renewable energy sources). Water used only for cleaning requirement. No water is used during production (the required water for the production

comes from the raw materials added to the mixture). A representative production loss at the product level was tracked by the plant and considered in the LCA calculations. All the production waste goes to landfill via lorry.

TRANSPORT AND INSTALLATION (A4-A5)

Transportation impacts occurred from final products delivery to construction site (A4) cover fuel direct exhaust emissions, environmental impacts of fuel production, as well as related infrastructure emissions.

PROMASEAL® products are delivered by road from the plant to the final customer. For the transportation from the production plant to the final customer, a scenario was assumed with a transportation distance of 100 km and using a lorry as transportation method.

Installation (A5) phase is not included in the scope of the EPD. Only packaging waste is included in module A5. Since the PROMASEAL® products become a part of another product, different applications and installation scenarios can be possible. Therefore, the installation scenario itself is not included.

PRODUCT USE AND MAINTENANCE (B1-B7)

The use phase is not included in the scope of the EPD, as a wide range of different applications and installation scenarios can be applied. The PROMASEAL® products become a part of another product. Therefore, Reference Service Life depends on the application. Under normal conditions of use, the product is supposed to remain its characteristics as long as the application lasts.

Air, soil, and water impacts during the use phase have not been studied.

PRODUCT END OF LIFE (C1-C4, D)

At the end-of-life, 100% landfill scenario is considered as the average European scenario for PROMASEAL® products. The consumption of energy and natural resources is negligible for disassembling of the end-of-life product since the PROMASEAL® products become a part of another product. Therefore, the impacts of demolition are assumed to be zero (C1).

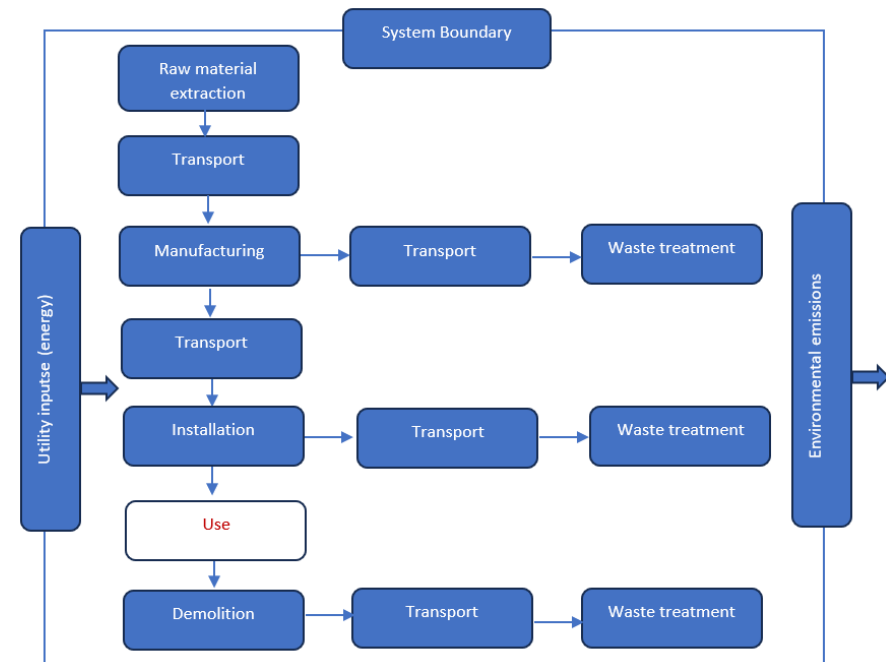
The transportation distance to the disposal area is estimated as 30 km via lorry. No benefits and loads regarding the product are allocated to module D, as the product is 100 % landfilled. However, some minor benefits and loads regarding the packaging of the product are allocated to module D.

MANUFACTURING PROCESS

DESCRIPTION

All raw materials are dosed and mixed according to specified process condition. The ready-mixed masses are packed in the respective containers and finalized based on the production order. The finished product is then packed and ready for transport. The quality is checked during production and after packaging.

See below the included life cycle stages within the system boundary of this study. The use phase (Module B) was not included in the system boundary. The installation phase (Module A5) only includes the packaging waste of the final product.



LIFE-CYCLE ASSESSMENT

CUT-OFF CRITERIA

The study does not exclude any modules or processes which are stated mandatory in the reference standard and the applied PCR. The study does not exclude any hazardous materials or substances. The study includes all major raw material and energy consumption. All inputs and outputs of the unit processes, for which data is available for, are included in the calculation. There is no neglected unit process more than 1% of total mass or energy flows. The module specific total neglected input and output flows also do not exceed 5% of energy usage or mass.

ALLOCATION, ESTIMATES AND ASSUMPTIONS

Allocation is required if some material, energy, and waste data cannot be measured separately for the product under investigation. All allocations are done as per the reference standards and the applied PCR. In this study, allocation has been done in the following ways:

There is no average result considered in this study since this EPD refers to one specific product, i.e., PROMASEAL®-A produced in one production plant. LCA calculations have been carried out for the other product covered in the EPD, i.e., PROMASEAL®-AG. A variation analysis has been conducted comparing the results of PROMASEAL®-AG vs the results for PROMASEAL®-A. The variation analysis confirmed that the maximal variation is below the allowable limit for the GWP-fossil for A1-A3 and as a result, PROMASEAL®-A is considered as representative for both products included in the EPD.

LCA SOFTWARE AND BIBLIOGRAPHY

This EPD has been created using One Click LCA EPD Generator. The LCA and EPD have been prepared according to the reference standards and ISO 14040/14044. The EPD Generator uses Ecoinvent v3.8, Plastics Europe, Federal LCA Commons and One Click LCA databases as sources of environmental data.
