

# URSA WALLTEC REFLEX

## **Description.**

URSA WALLTEC REFLEX is a non-combustible glass mineral wool insulation slab. It is treated with a silicon-based water repellent and features a micro-perforated aluminium foil on one side which is applied during the manufacturing process.



## Application.

URSA WALLTEC REFLEX is designed to be used as thermal and acoustic insulation for soffit insulation under concrete, timber or metal floors.

Declared thermal conductivity (lambda ( $\lambda$ ) value) of 0.032 W/mK.

Foil Emissivity: 0.10

**Cavity Resistance (Horizontal):** 0.57 m²K/W

#### Density:

Manufactured at a nominal density of 32 kg/m³.

#### Fire Classification:

Deemed non-combustible with a fire classification of Euroclass A1 (the highest possible rating) when tested to EN 13501-1:2018 Reaction to Fire.

## Handling & Storage.
